TUSCALOOSA TRACK CLUB MEMBERSHIP WAIVER: I know that running and volunteering in work in club races are potentially hazardous activities. Having read this waiver and knowing these facts, and in consideration of the acceptance of my application for membership, I, for myself and anyone entitled to act on my behalf, waive and release the Road Runners Club of America, the Tuscaloosa Track Club and all sponsors, their representatives and successors, from all claims or liabilities of any kind arising out of my participation in these club activities, even though that liability may arise out of negligence or carelessness on the part of persons named in this waiver.
